- The quotation should be enclosed in a sealed envelope.
- Firms will quote separately for each article.
- Opening of BIDS: Bid should be sent in sealed envelope should be submitted on 27.01.2017 at 2.30 pm. The Bids will be opened on the same day i.e 27.01. 2016 at 3.00 pm in the presence of tenderers or their authorized representative, if any. Unsealed quotations shall not be considered. - (i) The price of goods/services quoted F.O.R., CIAB at Annexure-'A'

Hence Excise Duty and Customs Duty, if any, should be shown separately. No other charges than those mentioned clearly in the quotation will be paid.
- (iii) The dealers/vendor must provide authorization letter from the principal.
- (iv) The charges for inland transportation, insurance and other local service required for delivering the goods/services at the desired destination as specified in the price schedule form.
- (v) The prices must be valid at least for a period of **90 days for indigenous supplies** & **180 days for imports** from the date of opening of the quotation.

- (ix) Specifications are basic essence of the product. It must be ensured that the offers must be strictly as per our specifications.
